The ground floor consists of a restaurant and kids playground area, an open space mezzanine, ancillary spaces and a one bedroom apartment . The first floor consists of an open space living, dining, kitchen and bar area, three bedrooms, of which the master bedroom includes a shower and a walk-in wardrobe, a main bathroom with a toilet, a guest toilet, a fireplace and access to a spacious covered veranda. Furthermore the property offers two storage areas and parking spaces. The asset is located 390m north of Griva Digeni avenue and approximately 4.4km south of Nicosia Mall. The property falls within Zone Γ3, with a building coefficient of 10%, coverage of 10%, and permission for 2 floors (8.3m) of construction.
