The asset is adjacent to Klimentos Street, c. 30m north of Digeni Akrita Avenue and c. 300m east of Makariou Avenue. The asset comprises of a 230sqm ground floor, a 176sqm mezzanine and a 116sqm basement. There is also a studio apartment of 38sqm on the mezzanine level. It has an exclusive right of use of a 122sqm yard, 11 uncovered parking spaces on the ground floor and one parking space in the basement. The immediate area of the asset is the commercial center of Nicosia that comprises of commercial and mixed-use developments.

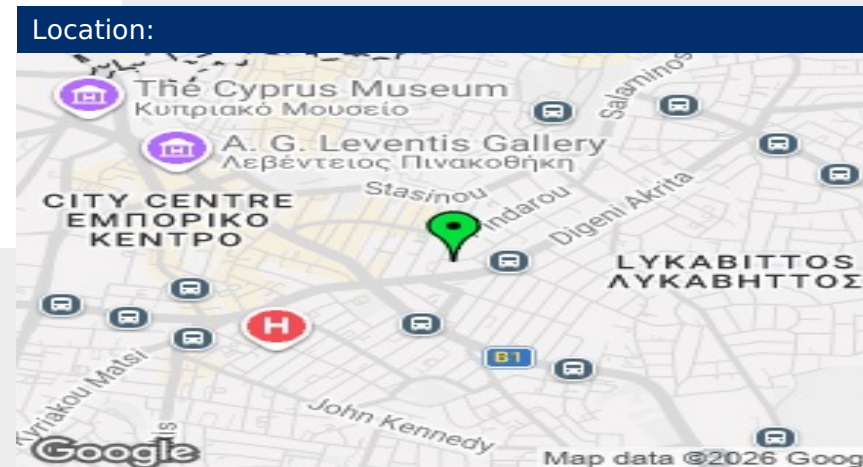
