Both floors feature parquet floors (raised floors), false ceiling , air conditioning, wiring and fire safety system. The asset benefits from the exclusive right of use of four parking spaces at the basement and is accessible through an exterior staircase from the ground level of the commercial center and overlooks Ayias Elenis Street.

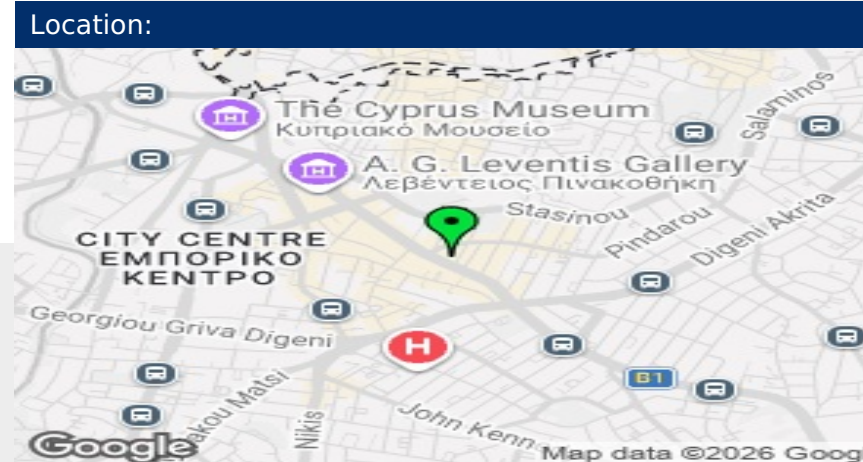
