The building consists of a ground floor carpentry workshop, a painting room, a canteen, a WC and a staircase providing access to the mezzanine. The mezzanine includes the administrative department with 3 offices and locker rooms/WC with showers. The property is built within a land area of 3,679sqm and benefits from a road frontage of 23m. On the east side of the building, there is a second mezzanine area which is used as a product exhibition space and storage. The property offers close proximity to all amenities and excellent access to the highway.

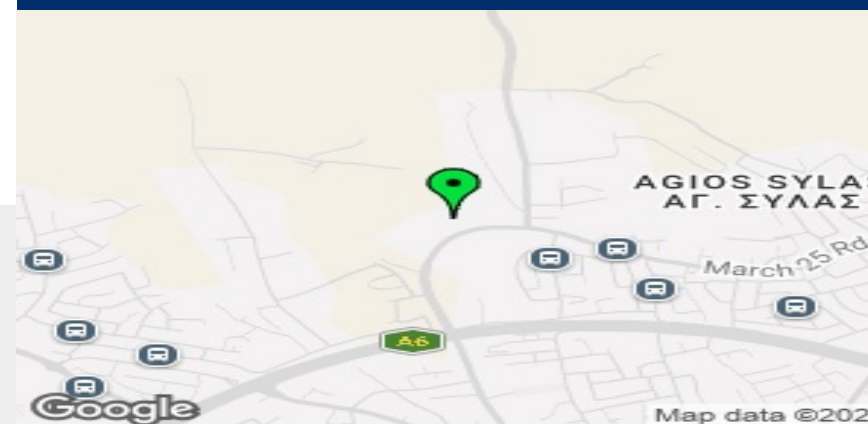
