The property is a collapsed listed house located in a land of 153sqm in Agios Antonios, Nicosia with close proximity to OXI roundabout in a historical neighborhood. Only the facade of the listed building remains on site while the roof and internal walls have collapsed, making it suitable for a brand-new interior design. The immediate area of the property is within the old city walls of Nicosia comprising of listed buildings of residential and commercial use and is the traditional commercial center of Nicosia. The property falls within residential planning zone Kα-α, with building density coefficient of 140%, coverage coefficient 70%, in 2 floors and a maximum height of 8m height.

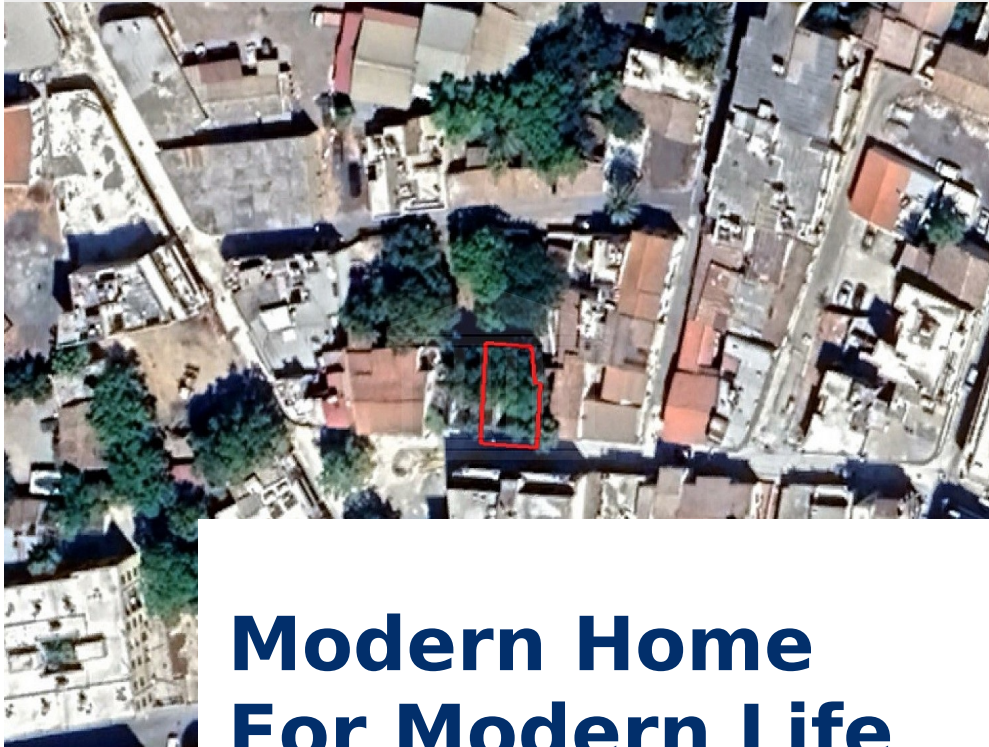

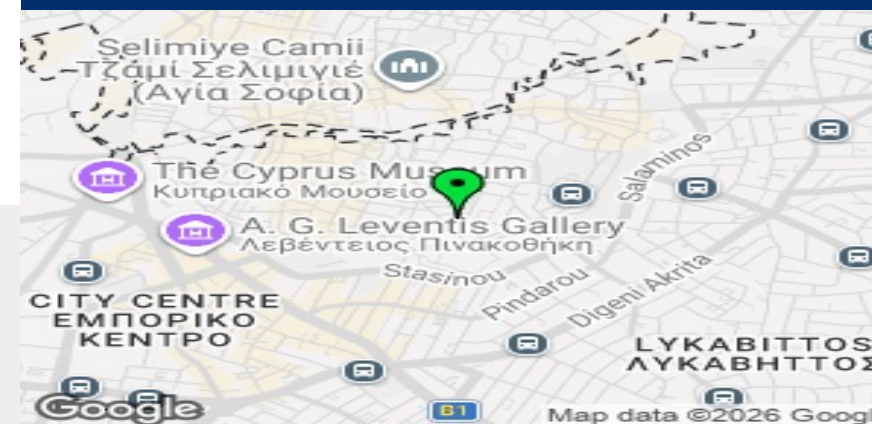
